Re: Proposed amendments to the ACC Hearing Assessment Regulations

- 1.1 I am writing to you as Convenor of the New Zealand Law Society | Te Kāhui Ture o Aotearoa Accident Compensation Committee (ACC Committee), regarding MBIE's *Proposed amendments to the Accident Insurance (Occupational Hearing Assessment Procedures)*Regulations 1999 Consultation Paper (Consultation Paper).
- 1.2 The ACC Committee is concerned that the proposal in the Consultation Paper to update the age scale based on ISO 7029:2017¹ has a disproportionate effect on female claimants. While, as noted, Option 2 would result in a total of 1321 additional accepted claims, that is a net benefit for male claimants only 1173 women who had previously been accepted would now be declined, compared with just 151 women who had previously been declined, now being accepted.²
- 1.3 The ACC Committee accepts that the proposed changes are based on the new international standard ISO 7029:2017. However, as the standard is based on epidemiological data, the datasets will relate to generations of women who are less likely to have undertaken work with significant occupational noise. Those datasets do not necessarily reflect the shifting demographics of roles with significant noise exposure.
- In a recent letter to the Law Society (appended), the Minister for ACC noted that her priority over the course of this term of government is to improve equity within the ACC Scheme, with a focus on women, Māori, and Pāsifika peoples. Given that the Minister for ACC has emphasised the importance of equity for female claimants under the ACC scheme, the ACC Committee proposes the adoption of Option 2 for male claimants, but the retention of Option 1 (i.e., maintaining the current age scale based on ISO 7029:1984) for female claimants.
